SHOW RULES AND REGULATIONS

1. This show is sponsored and produced by the TEXAS APPALOOSA HORSE CLUB, INC. and approved by the Central Texas Appaloosa Horse Club, Dal-Worth Appaloosa Horse Club, Texas Appaloosa Cutting Horse Assoc., Texas Appaloosa Horse Club, Texas Appaloosa Youth Horse Club, and the Appaloosa Horse Club, Inc., Moscow, Idaho. Judges' and officials' decisions are final.
2. All horses must be registered for show purposes by the Appaloosa Horse Club, Inc. Registration Certificates on all horse (copies are permissible) must be available for submission to the Show Management by ApHC rules.
3. **All owners and exhibitors must be a member of the ApHC to show and proof must be shown at time of registration. If you do not have this, you will have to purchase a membership and then get your refund at a later date as per ApHC rules.**
4. Horses will be judged in accordance with the rules of the Appaloosa Horse Club, Inc., and the Texas Appaloosa Horse Club.
5. Stall fees will be collected with entry fees. A one time grounds fee will be charged per horse if a stall is not used. **HOT Fairgrounds does not allow shavings to be brought on to the grounds. You must purchase from them.**
6. All protests must be filed in accord with T.A.H.C. rules (paragraph 19).
7. The Show Management reserves the right to refuse entries, take entries conditionally, or to cancel or consolidate classes in which there are not sufficient entries.
8. Any person calling to order cattle and not showing will be billed their cattle charge and not allowed to show until that fee is paid in full.
9. **ALL HORSES THAT COME ON TO THE SHOW GROUNDS MUST HAVE A NEGATIVE COGGINS TEST WITH IN 12 MONTHS. YOU MUST BRING THESE TO THE SHOW OFFICE AND THEY WILL BE DOCUMENTED. IF YOU DO NOT DO THIS, YOU WILL BE LIABLE FOR ALL AND ANY FINES ASSESSED BY THE TEXAS ANIMAL HEALTH COMMISSION UNDER THEIR NEW RULES.**
10. High Point and Reserve Point Youth and Non-Pro ties will be broken by the youth or non-pro with the highest total of points accumulated in the following four (4) classes: (1) Showmanship at Halter, (2) Hunt Seat Equitation, (3) Western Equitation, & (4) Keyhole.
11. Any RETURNED CHECKS WILL BE CHARGED A \$30.00 FEE.
